PROPOSED CONSTRUCTION OF ZANZIBAR FOOD AND DRUG AGENCY OFFICE BUILDING AT MOMBASA ZANZIBAR.

The Revolutionary Government of Zanzibar through Zanzibar Food and Drugs Agency has set-aside funds, it is intended that a part of the proceeds of this fund will be applied to eligible payment under the contract for **Proposed Construction of Zanzibar Food and Drugs Agency Office Building to be built in two phases based on the financial year disbursement.**
2. The Zanzibar Food and Drugs Agency now invites sealed tenders from eligible Contractors for Proposed Construction of Zanzibar Food and Drugs Agency Office Building to submit tender for eligible and qualify bidder.
3. Tendering will be conducted through the **National competitive Bidding procedures** as specified in the Public Procurement Act No 11 of 2016 (Goods, Works and Disposal of Public Assets by Tender) regulation, 2006-Government notice No.62 and is open to all Renderers as defined in the Regulation.

Tenders shall be valid for a period of **Ninety (90) days** after Tender opening and must be accompanied by a **bid security Declaration and must be addressed to the Executive Director Zanzibar Food And Drugs Agency P.O.BOX 3595 Zanzibar.** All complete sealed Tender must be delivered physically to an address indicated above before the deadline for submission of Tenders.
7. The deadline for submission of tenders is **23th October, 2018 at 14:00** hrs local time.
